ENTERGY NEW ORLEANS, LLC'S UNOPPOSED MOTION TO MODIFY THE PROCEDURAL SCHEDULE

Entergy New Orleans, LLC ("ENO") respectfully submits this Unopposed Motion to Modify the Procedural Schedule in the above-captioned Docket. Specifically, for the reasons stated herein, ENO requests that the dates set forth in Council Resolution No. R-19-109 at Ordering Paragraph 4(E)(F) be modified as follows: (i) that the date by which Comments regarding the Advisors' Report and Draft Renewable Portfolio Standard ("RPS") be changed from October 1, 2019 to October 15, 2019, and (ii) that the date by which the Reply Comments regarding the Advisors' Report and Draft RPS be changed from October 15, 2019 to November 12, 2019.

1.

On March 28, 2019, the Council initiated Docket UD-19-01 via Council Resolution No. R-19-109. Resolution No. R-19-109 established certain procedural deadlines, appointed the Honorable Judge Jeffrey Gulin as the Hearing Officer in this Docket, and vested Judge Gulin with the authority to "change or amend the procedural dates" set forth in the Docket.

2.

To date, the following entities have intervened in the proceeding: the Alliance for Affordable Energy ("AAE"), Air Products and Chemicals, Inc. ("APC"), the Center for Climate and Energy Solutions ("C2ES"), Audubon Louisiana, the Sierra Club, the Southern Renewable

Energy Association, the Gulf States Renewable Energy Industry Association ("GSREIA"), 350 New Orleans, PosiGen Solar, and Vote Solar (collectively, the "Parties").

3.

On June 1, 2019, the Parties filed Comments in alignment with the procedural deadline set forth in Resolution No. R-19-109.

4.

On July 15, 2019, several Parties filed Reply Comments, following an Order from the Hearing Officer modifying the procedural deadline set forth in Resolution No. R-19-109. In addition to filing Reply Comments, a group of intervenors and other entities, styling themselves the Energy Future New Orleans Coalition, filed a proposed rule.

5.

On September 3, 2019, the Council Advisors filed a Report with the Council. The Advisors' Report contained three Alternative Rules for the Parties to comment upon and the Council to consider.

6.

Given the extensive nature of the comments submitted to date, and the fact that the Advisors' Report contains three Alternative Rules, ENO believes that additional time for the Parties to develop their Comments and Reply Comments is warranted.

4.

ENO has contacted the Parties seeking any objections to the requested relief sought herein. As of the filing of this Motion, no party has objected to the relief requested and the Advisors, AAE APC, Audubon Louisiana, C2ES, GSREIA, and Vote Solar have affirmatively indicated they have no objection to the relief requested herein.

WHEREFORE, Entergy New Orleans, LLC respectfully requests that its Unopposed Motion to Modify the Procedural Schedule be GRANTED and that the dates set forth in Council Resolution No. R-19-109 be modified as follows: (i) that the date by which Comments regarding the Advisors' Report and Draft Renewable Portfolio Standard be changed from October 1, 2019 to October 15, 2019, and (ii) that the date by which the Reply Comments regarding the Advisors' Report and Draft Renewable Portfolio Standard be changed from October 15, 2019 to November 12, 2019.
