

**ENERGY NEW ORLEANS, LLC’S
UNOPPOSED MOTION TO MODIFY PROCEDURAL SCHEDULE**

Energy New Orleans, LLC (“ENO”) respectfully submits this Unopposed Motion to Modify the Procedural Schedule in the above-captioned Docket. Specifically, for the reasons stated herein, ENO requests that the dates set forth in Council Resolution No. R-19-111 be modified as follows: (i) that the date by which the meeting of the parties must occur be changed from May 1, 2019 to June 1, 2019, and (ii) that the date on which ENO must submit “its proposed CSG application procedure and its proposed Standard Interconnection Agreement for CSG facilities” be changed from May 1, 2019 to July 30, 2019.

On June 21, 2018, the Council initiated Docket UD-18-03 via Council Resolution No. R-18-223. Resolution R-18-223 established certain procedural deadlines, appointed the Honorable Jeffrey Gulin as the Hearing Officer in this Docket, and vested Judge Gulin with the authority to “change or amend the procedural dates” set forth in the Docket.

2.

Following the completion of the process set out in Resolution R-18-223, at the December meeting of the Council for the City of New Orleans’ (“Council”) Utility, Cable, Technology, and Telecommunications Committee (“UCTTC”), the UCTTC advanced a draft Resolution that made certain findings and contained additional procedural deadlines for Docket UD-18-03. However,

due to considerations not implicated in the context of this Unopposed Motion, the full Council did not act on the draft Resolution in December 2018.

3.

At the March meeting of the UCTTC, the Committee considered and adopted a modified version of the draft Resolution introduced at the December UCTTC meeting. On March 28, 2019, the full Council adopted Resolution No. R-19-111, which set forth additional procedural deadlines for this Docket.

4.

Resolution R-19-111, as adopted by the Council, set the deadline for ENO's filing of "its proposed CSG application procedure and its proposed Standard Interconnection Agreement for CSG facilities" as 90 days from February 1, 2019 – or May 1, 2019. However, the Council's reference to February 1, 2019 as the start of the computation period for this deadline appears to be a "carryover" from the December 2018 draft Resolution. ENO understands that the Council intended to adopt language setting May 1, 2019 as the starting date of this computation period, which would make the deadline July 30, 2019. ENO respectfully requests that the Hearing Officer modify the procedural schedule accordingly.

Resolution R-19-111 also requires that ENO hold a meeting of the parties to discuss its proposed CSG application procedure, its proposed Standard Interconnection Agreement for CSG facilities, and any other issues on or before May 1, 2019. ENO believes that such a meeting would be more productive if ENO has more time to work on the required filings prior to conducting the meeting. As such, ENO respectfully requests that the Hearing Officer modify the deadline for this meeting to be on or before June 1, 2019.

6.

ENO has contacted the parties to this Docket seeking any objections to the requested relief sought herein. As of the filing of this Motion, no party has objected to the relief requested and the Advisors have indicated they affirmatively support the relief requested.

WHEREFORE, Entergy New Orleans, LLC respectfully requests that its Unopposed Motion to Modify the Procedural Schedule be GRANTED and that the dates set forth in Council Resolution No. R-19-111 be modified as follows: (i) that the date by which the meeting of the parties must occur be changed from May 1, 2019 to June 1, 2019, and (ii) that the date on which ENO must submit “its proposed CSG application procedure and its proposed Standard Interconnection Agreement for CSG facilities” should be changed from 90 days from February 1, 2019 to 90 days from May 1, 2019 – or, July 30, 2019.
